




Are you aware of the Electronic Archiving Trust Service which is being discussed for the elDAS 2 Regulation?






When approved, are you planning to be certified as an Electronic Archiving Trust Service?






Do you think using eArchiving specifications for information packages helps to implement eIDAS Electronic Archiving Trust Services?




